4. How we generate stories, images & audio

We send your prompts to third-party AI providers (e.g. **OpenAI**, **ElevenLabs**, **Google**) under strict contracts. Prompts and generated outputs are retained on our servers so you can access them later; we do **not** use them to retrain our own models.

5. How we share data

6. International transfers

Some partners are outside the EEA. We rely on **Standard Contractual Clauses** and comparable safeguards to protect your data.

7. Retention & deletion

Data Retention

Account & purchase records While the account is active + 6 years (tax law) AI-generated stories/images/audio Until you delete them or delete your account

Logs & analytics ≤ 12 months

"Marked for deletion" accounts Permanently erased 7 days after request

You can delete your account at any time in Settings \rightarrow **Delete Account**. Deletion is irreversible.

8. Your rights (EU / EEA & similar laws)

You may access, correct, erase, port, restrict or object to processing of your personal data.

To exercise these rights, e-mail **privacy@owlystories.com** or use the in-app request form. We will respond within 30 days.

9. Children's privacy

The App is designed for parents or legal guardians to create stories **for** children. We do not knowingly collect data directly from children under 13 (US COPPA) or 16 (EU). If you believe we have unintentionally collected such data, contact us and we will delete it promptly.

10. Security

We use encryption in transit (TLS 1.2+), hashed passwords, least-privilege API keys and continuous monitoring. No system is 100 % secure, but we take reasonable technical and organisational measures to protect your data.

11. Disclaimer & limitation of liability

We provide the App and generated content "as is". To the maximum extent permitted by law, we disclaim all warranties and will not be liable for any indirect, incidental or consequential damages arising from the use of the App or the content it generates.

12. Changes to this policy

We may update this policy to reflect legal or operational changes. If changes are material we will notify you in-app or by e-mail. Continued use of the App means you accept the revised policy.
